- Speaker this month: Our speaker at our June meeting was Emma Minehart, the Director of the Calaveras County Historical Society & Museum Emma gave an excellent talk about the Historial Society. Society created in 1952 by Judge Smith. Not many residents of Calaveras know that there is a historical society or two museums in San Andreas. The museums are in the old courthouse and the old dairy building. The museums focus on the people and industry of Calaveras. They offer school tours and are focusing on preservation of the history and artifacts. There are four hundred and sixty members of the society, mostly older folks. Update by Woodward and Curran on the Calaveras River Watershed Resiliency Plan by Katie Evans- Katie presented earlier this year and this is an update. California Department of Water Resources has provided a grant and Woodward and Curran is working to develop a watershed plan based on technical and community input. Their plan is to develop a water management plan based on the technical modeling and community input. They are looking at what hydrology will look like depending on different climate modeling. Attached is a document on the work to date. Specifically, Katie asks that folks <u>visit their website</u> to review what is being done and to provide input. Marcie Powers provided an excellent debriefing on the Calaveras Fire & Film & Forum Festival – Key learnings are that forest fires are started by people 85% of the time. It happens that more often fires start in communities and spread to the forest than from the forest to communities. That in addition to defensible space by thinning the forest around our homes, the importance of "home hardening" was explained. Going forward Red Cross is interested in bringing fire hardening to the homes around the State Park to protect the Giant Sequoias from a fire that starts in an adjacent community. In Marcie's talk she mentioned a June date to work on presenting fire hardening to the homeowners who are adjacent to the Park, but that has been rescheduled for tentatively October. The Chief provided an excellent detailed explanation of what the Gann limit is and what it would mean if it did not pass or did pass.
