Speaker this month: Samantha Lukow, MHA, Executive Director, Hospice of Amador & Calaveras Sam gave an incredible compassionate introduction to the services offered by Hospice of Amador and Calaveras. Hospice of Amador & Calaveras in existence for forty two years. It is non-profit, unlike many of the current for-profit hospice corporations. Hospice is not for the last few days of life; it is for at least six months. Qualification elements are assessed to see if hospice is appropriate at that point in time. She spoke passionately about the difference between for-profit and non-profit hospice corporations. Laura asked how hospice is contacted. 80% of hospice referrals come from family and friends. North Fork and Beaver Creek are stocked with trout. Parkway opened to South Grove. Campsites all open by 15th of May. Heather and the team that planned the South Grove prescribed burn last year were awarded a special award for the planning and execution.
